Liability Waiver Related to COVID-19 and Variants

The novel coronavirus and its variants, identified as SARS-CoV-2 or "COVID-19", has been declared a worldwide pandemic by the World Health Organization. On March 13, 2020, United States President Donald Trump declared a national emergency regarding the COVID-19 pandemic. On February 24, 2021, President Joseph Biden issued a continuance of the national emergency declaration concerning the COVID-19 pandemic.

The COVID-19 virus is contagious and primarily spread from person-to-person contact. In combating and reducing the risk of transmission of the COVID-19 virus and its variants, public health guidance is continuing to evolve. The Intertribal Agriculture Council ("IAC") has implemented measures consistent with regulations, orders, and public health guidance. However, at IAC hosted events, IAC cannot guarantee that its participants or others in attendance will not be exposed to COVID-19.

ASSUMPTION OF THE RISKS. I acknowledge and understand that while IAC has undertaken reasonable actions to lessen the risk of transmission of COVID-19 at IAC hosted and managed events, IAC is not responsible in any manner for any risks related to COVID-19 in my participation at any IAC event. I understand that the World Health Organization has classified the COVID-19 outbreak as a global pandemic and that COVID-19 is a highly contagious and dangerous disease. I further understand that contact with the COVID-19 virus may result in significant personal injury or death. I am fully aware that participation in an IAC event carries inherent risks related to COVID-19 transmission that cannot be eliminated regardless of the care taken to avoid such risks. I acknowledge that I benefit from my participation in an IAC event and I willingly engage in this IAC event. I hereby knowingly assume the risk of injury, harm and loss associated with my participation at this IAC event.

RELEASE AND WAIVER. I hereby release, waive and forever discharge any and all liability, claims, and demands of whatever kind or nature against the Intertribal Agriculture Council, including in each case, without limitation, their directors, officers, employees, volunteers, and agents ("Released Parties"), either in law or in equity, to the fullest extent permissible by law, including but not limited to damages or losses caused by the negligence, fault or conduct of any kind on the part of the Released Parties, including but not limited to death, bodily injury, illness, economic loss or out of pocket expenses, or loss or damage to property, which I, my heirs, assignees, next of kin and/or legally appointed or designated representatives, may have or which may hereinafter accrue on my behalf, which arise or may hereafter arise from my participation with an Intertribal Agriculture Council event.
